This year, 2023, marks the 50th Anniversary of the Endangered Species Act, one of the most influential pieces of legislation that has impacted conservation in the United States. We will celebrate the successes and document lessons learned from the past 50 years and discuss how to apply those lessons to the next 50 years of conservation work. The overall goal of this symposium is to celebrate 50 years of the ESA through a private land stewardship lens and look ahead to prepare the next generation of conservation leaders.

# JAMES G. TEER CONSERVATION LEADERSHIP INSTITUTE

This symposium was organized by the fellows of the James G. Teer Conservation Leadership Institute (JGTCLI) which is sponsored by The Texas Chapter of The Wildlife Society. The mission for the JGTCLI is to ensure a future legacy of well-trained conservation leaders by providing professional training in leadership skills and contemporary conservation issues for today's wildlife biologists and conservation professionals. The institute believes that there is a current need for a Texas-based leadership program that not only meets the needs of biologists and conservation professionals, but also focuses on the unique issues associated with Texas' private lands. As one of the founding goals of the program, cohort members should be knowledgeable of conservation concepts and contemporary conservation issues so they may successfully understand and manage Texas' wildlife and natural resources. As such, the program includes a team-based project on current natural resource issues facing that state.



# **JGTCLI Cohort & Panelist Bios**

#### Addie Smith Geospatial Analyst, TAMU NRI



Addie Smith is a geospatial analyst and program coordinator at the Texas A&M Natural Resources Institute. Using geospatial data, she examines new patterns and identifies trends to provide key information for complex Texas natural resource challenges through the power of "good map."

She joined the institute as a student technician in 2012 and received a Bachelor of Science in wildlife and fisheries sciences in 2014 from Texas A&M University. As Assistant Director, Gary is the senior career official responsible for policy development, budget, and oversight for the Fish and Wildlife Service's administration of the Endangered Species Act, Marine Mammal Protection Act, Fish and Wildlife Coordination Act, Coastal Barrier Resources Act, and other environmental protection authorities delivered through the Service's Ecological Services program and field stations.

Gary grew up in a small farming community in southeastern Iowa. He earned a B.S. in Fisheries and Wildlife Biology from Iowa State University in 1977 and an M.S. degree in Forestry with a Wildlife Specialty from Purdue University in 1981. Gary and his wife live in Herndon, Virginia.

#### Jimmy Bullock Senior Vice President, Forest Sustainability, Resource Management Service LLC

As Senior Vice President Forest Sustainability for Resource Management Service, LLC (RMS), Jimmy oversees sustainable forestry, environmental policy and programs, and advocacy on forestry issues for RMS-managed timberlands in the United States. He also leads environmental, social and governance (ESG) initiatives for RMS-managed timberlands globally.

Jimmy earned his B.S. degree in Forestry and his M.S. degree in Wildlife Ecology from Mississippi State in 1980 and 1982 respectively. A TWS Certified Wildlife Biologist, Mississippi Registered Forester and SAF Certified Forester, Jimmy is on the Board of Directors for the National Conservation Leadership Institute, the Catch-A-Dream Foundation, Wildlife Management Institute, Forest Landowner's Association, Amphibian and Reptile Conservancy, and Mississippi Wildlife Federation. #### Douglas Wheeler ESA Author



Douglas P. Wheeler graduated from Hamilton College (B.A.) in 1963, and Duke University School of Law (LL. B.) in 1966. Thereafter he served in the U.S. Army, and thence joined the U.S. Naval Reserve JAG corps. Wheeler has worked exclusively with natural resources and environmental issues throughout his career. He joined the Department of Interior in 1969 where he served as Assistant Legislative Counsel, and then Deputy Assistant Secretary for Fish, Wildlife and Parks under Assistant Secretary Nathaniel Reed, during which time he participated in the drafting of the Endangered Species Act of 1973 with Reed and Buff Bohlen and testified in the Congressional hearings. Afterward, Wheeler became Executive Director of the National Trust for Historic Preservation (1977 – 1980); President of the American Farmland Trust (1980 – 1985); Executive Director of the Sierra Club (1985 – 1987); Vice President of the World Wildlife Fund (1987 – 1991); and California Secretary for Resources, a cabinet level position (1991 – 1999). Wheeler has since practiced law with Hogan and Lovells in Washington, D.C., and today serves as Senior Counsel.

#### Peg Romanik Retired DOI Office of the Solicitor

Peg is a recently retired lawyer for the Department of the Interior. She ended her career as the Associate Solicitor for Parks and Wildlife, the highest career lawyer for the US Fish and Wildlife Service and the National Park Service. Peg spent the last 30 years of her career working on conservation, and in particular Endangered Species Act (ESA), legal issues. For decades here area of expertise was section 7 of the ESA, but she also focused on section 10 issues related to private landowners' compliance with the ESA. She worked with literally hundreds of FWS folks, private parties, other government agencies, and public and private attorneys to help implement the ESA. Peg received her law degree from the University of Notre Dame. She lives in Washington, D.C. And, her daughter is a proud Longhorn, class of 2012.



#### **Terry Anderson** CEO, Conservation Equity Partners, LLC



Terry Anderson is a biologist, a forester, and a conservation entrepreneur, who has spent the last 31 years successfully operating in a broad range of eco-system markets. His latest efforts have focused on developing Conservation Equity Management, LP, a Texas based, natural resource, private equity firm, created in 2021. The firm has a unique perspective that centers around investment in natural capital. Anderson is also co-founder and CEO of Conservation Equity Partners, LLC, and a co-owner of Wildlife Systems, Inc.

Additionally, Anderson often assists at Stephen F. Austin State University's Arthur Temple College of Forestry with habitat management and wetland ecology courses. He acts as a Board Trustee for the Texas Wildlife Association Foundation and is philanthropically involved with the Texas Wildlife Association and the Texas Forestry Association.

Anderson is well-versed in conservation finance strategies and federal environmental policy while believing in and advocating for the merits of "*Good to Great*" principles in the business world. Working with private equity groups, venture capitalists, landowners, state and federal regulators, and land trusts, he concentrates most of his time and energy on developing integrated conservation and mitigation projects. While primarily focused on the southeastern US, Anderson has assisted in the development of mitigation projects in markets as wide ranging as Alaska and Colombia, South America. Over his career, he has been involved in developing more than 30 mitigation banks and countless other conservation projects.

Anderson has a passion for revitalizing wetlands ecosystems and restoring native species and was most recently recognized as the 2022 Land Steward of the Year, by the Texas Chapter of the Wildlife Society.

#### **Ryan Orndorff** Director of Environmental Planning and Conservation, DoD Natural Resources Program

Ryan Orndorff is the Director of Environmental Planning and Conservation for the Office of the Deputy Assistant Secretary of Defense for Environment and Energy Resilience. He leads a team of experts that provides DoD-wide policy and program oversight for natural and cultural resource management and stewardship, Native American Affairs, environmental planning and environmental justice. Mr. Orndorff has worked in various capacities within DoD for nearly 20 years focusing on natural resources conservation and management, landscape-scale planning and partnerships, conservation policy and regulatory issues.



#### Bryan Arroyo Retired, USFWS



Bryan Arroyo retired from the U.S. Fish and Wildlife Service in December 2022. With over 30 years of experience, Bryan served at field, regional and national offices of the Service. Most recently, he served as Assistant Director, International Affairs. In this capacity, he oversaw the Service's work to coordinate domestic and international efforts to protect, restore, and enhance the world's diverse wildlife and their habitats with a focus on species of international concern, including domestic species that extend beyond our borders or are traded internationally. Bryan served as the Service's Deputy Director of Operations, overseeing the day-to-day operations of the Service, including providing executive direction through the Regional Directors, Native American programs, Diversity and Inclusion, and the National Conservation Training Center. Bryan also served as Assistant Director for Fisheries and Habitat Conservation and Endangered Species. Bryan attended the public school system in Puerto Rico, attended Catholic University of Puerto Rico and graduated in 1988 with a bachelor's degree in science with a major in biology. In 1991, he earned a master's degree in science with a major in Zoology from the University of Arkansas. He is married, has two daughters and a granddaughter. Bryan is an outdoor enthusiast and particularly enjoys fishing, hiking, and nature photography.

#### Dave Tenny CEO, National Alliance of Forest Owners

Dave Tenny is the founding President and CEO of NAFO. Under his leadership, NAFO has grown from 14 initial members in 2008 to 48 member companies that own and manage 46 million acres of private working forests and 34 state and national associations that represent tens of millions of additional acres. Dave's passion for building trust and pursuing solutionsbased advocacy has helped NAFO become a leading national advocate committed to advancing federal policies that ensure our working forests provide clean air, clean water, wildlife habitat and jobs through sustainable practices and strong markets.

Dave previously served as Vice President for Forestry and Wood Products for the American Forest and Paper Association (AF&PA) and as Deputy Undersecretary for Natural Resources and Environment at the United States Department of Agriculture where he had responsibility for the U.S. Forest Service. He got his start in the U.S. House of Representatives where he served as Counsel and Natural Resources Policy Advisor for the House Committee on Agriculture and as Counsel for U.S. Representative Wally Herger of California.

A native of Boise, Idaho, he earned a bachelor's degree in American studies from Brigham Young University in Provo, Utah, and a law degree from George Washington University in Washington, D.C.



#### Lindsay Martinez Research Program Coordinator, East Foundation



Lindsay Martinez is a Research Program Coordinator within the Science Division of the East Foundation, which has a mission to promote land stewardship through research, ranching, and education across more than 200,000 acres of ranchland in South Texas. Martinez has experience coordinating with private landowners, conservation organizations, universities, and agencies to plan policy for the conservation of endangered ocelots on East Foundation lands and other private lands in South Texas. In 2022, she was the first recipient of the Ronald F. Labisky Graduate Fellowship in Wildlife Policy.

Chad Ellis is the Chief Executive Officer for Texas Agricultural Land Trust (TALT). Mr. Ellis has over 25 years of experience working directly with producers and land managers implementing stewardship focused management. Ellis not only promotes and advocates land stewardship principles, and he also implements it within his own family operation in Lohn, Texas. Mr. Ellis is passionate about helping empower the producer to be better tomorrow than they are today.

Ellis brings deep connections and experience as chair to US Roundtable for Sustainable Beef (USRSB), chairman for Ecosystem Service Market Consortium (ESMC) and the founding chair of Trust in Food's Trust in Beef program.

#### **Mike Leahy**

#### Senior Director of Wildlife, Hunting, and Fishing Policy for National Wildlife Federation

Mike Leahy is Senior Director of Wildlife, Hunting, and Fishing Policy for National Wildlife Federation, where he leads policy efforts related to wildlife and biodiversity. Leahy's priorities include improving coordination among wildlife supporters, plugging gaps in wildlife and biodiversity policy, and building out a comprehensive network of lands and policies to sustain all species into the future. Issues include funding federal, state and tribal wildlife programs; establishing programs to maintain wildlife movements; addressing wildlife disease and other threats; and wildlife laws. Previously, he was Conservation Director for the Izaak Walton League of America, Regional Director for Defenders of Wildlife, and Forest Campaign Director for National Audubon Society. Leahy holds a J.D. from Georgetown University and a B.S. in Natural Resources from Cornell University.



#### **Gian Basili** Deputy State Supervisor, Ecological Services



Gian Basili has a Ph.D. in Wildlife Ecology from the University of Wisconsin-Madison and has been working in Florida on landscape-scale conservation and restoration for more than 25 years. For 17 of those years, he worked for the St. Johns River Management District where he held numerous positions gaining skills at managing complex projects with large teams and budgets. He joined the USFWS in 2016 as the Coastal Program Coordinator for North Florida , served two years as the Florida Air Force Partnership Coordinator, and is currently the Deputy State Supervisor for Ecological Services.
